Prosecco Cycling - Limited Liability Amateur Sports Company - under the auspices of ACSI Ciclismo, organizes the event named Prosecco Cycling on **Sunday 29 September 2024**, in Valdobbiadene (TV), Italy.

Art. 1 PARTICIPATION

Paragraph 1. The number of Participants is limited to **2500** places. Participation is accepted with any type of bicycle (racing, touring, electric, gravel bike, tandem, mountain bike, recumbent, handbike). According to the provided forms the Participants of both sexes can submit as follows:

a) ITALIAN LICENSED PARTICIPANTS, aged from 18 to 75, owing a Card issued by ACSI Ciclismo, F.C.I. or Bodies in direct agreement with the same or Bike Card but recognized by C.O.N.I. valid for the year 2024 and **only** if in possession of the **valid medical certificate for competitive cycling activities as per art. 4 of the Ministerial Decree 16 / 24.04.2013** (see fac-simile); all that to be presented on the day of call for the collection of technical box and gift box.

b) FOREIGN LICENSED PARTICIPANTS, aged from 18 to 75, owing a license issued by their National Cycling Federation and **only** if in possession of the **valid medical certificate for competitive cycling activities** (see fac-simile) **as per art. 4 of the Ministerial Decree 16 / 24.04.2013**; all that to be presented on the day of call for the collection of technical box and gift box.

c) ITALIAN LICENSED TOURING CYCLIST PARTICIPANTS must **compulsorily attach**, at the time of the online admission request, a copy of the **valid medical certificate for competitive cycling** (see fac-simile) **in compliance with art. 4 of the Ministerial Decree 164 / 24.04.2013**; all that to be shown on the day of call for the collection of technical box and gift box.

d) ITALIAN AND FOREIGN NON LICENSED PARTICIPANTS in a Company and/or Sports Association and **licensed foreign Cyclists without U.C.I. license**, aged from 18 to 75, to participate must **necessarily pay, in addition to registration fee**, the amount of **€ 16.00** to start the **multi-risk insurance policy + RCT** (see policy) which coverage is valid only for the duration of the event and is **non-refundable** in case of non-participation.

Paragraph 2. Multiple membership in ACSI Cycling, F.C.I. and in one or more Sports Promotion Bodies or in foreign Federations is forbidden.

Paragraph 3. For non-affiliated Italian and foreign Participants, as well as for Italian and foreign Participants affiliated without a UCI license, it is **mandatory** to attach, along with online admission application, **valid medical certificate for competitive cycling in accordance with Article 4 of D.M. 164/24.04.2013**, (see fac-simile), to be presented in **original** format at the time of **call** to collect technical and gift box. A valid national identity document must also be presented, as required by Article 38 of D.P.R. 44/2000. Said certificate must not be dated more than one year prior to the date of event in which participation is intended. Otherwise, participation is not allowed.

Paragraph 4. The subjects mentioned in art. 3.6 and 4 of the ACSI Cycling Technical Regulations 2024 cannot submit admission request.

Art. 2 ADDITIONAL OBLIGATIONS RELATING TO THE ADMISSION REQUEST

Paragraph 1. By signing the application request or, in any case, by payment of the registration fee, each Participant undertakes to comply with these Regulations as well as to maintain a diligent and prudent behavior during the Event. He also declares and confirms that:

a) He is in possession of a **regular medical certificate for competitive cycling activities** and he exempts and holds harmless the Organizer from any liability;

b) He read the information concerning the processing of Personal Data of Participants and consents to the processing of particular categories of data for the purposes of carrying out the pre- and contractual measures, better described in point 1 of the Information Sheet, as well as to the use and/or diffusion and/or publication - including on the website and social profiles of Prosecco Cycling Sporting Event and/or in any case connected to the Event, as well as through other systems (e.g. brochures, flyers, etc.) - of audio and video recordings, as well as stationary and/or moving photographic images, without territorial limits, made on the occasion of Prosecco Cycling Sporting Event or other Races/Events organized by the same, for promotional, informative, archive, concerning the activity of Data Controller on personal data of Participants and he is aware that installation and use of images and audio/video recordings is intended as granted indefinitely;

c) He is aware that participation in Prosecco Cycling 2024 is a potential risk activity and consequently He assumes all risks deriving from participation in the Event: such as: sickness, fall, contacts and/or collisions with vehicles, other Participants, Spectators and/or other and/or for accidental events prejudicial to safety that may also occur because of adverse weather conditions and/or road traffic and/or conditions of the road surface;

d) He is aware that the Organizer is not responsible for any vandalism, theft, prejudicial events of any kind the Participants may suffer from anyone in the different phases of the Event and that the custody of any object (thing) remains entrusted to each Participant;

e) He is aware that, at the end of the Event, the Organizer will make available to Participants a **guarded bike park** located at Villa dei Cedri, Valdobbiadene, Via Piva, to be utilized **only on Sunday 29 September 2024** from **h. 11:30 to h. 16:00**;

f) He therefore exempts from any liability, without exception, Organizer, Volunteers and all Staff employed by Organizer, for any damage occurring during the Event as a direct and/or indirect consequence of declarations, facts, circumstances, or physical conditions or conditions attributable to a violation of these Regulations carried out on their own and/or by other Participants and/or by situations external to the Event;

g) Have read and to scrupulously comply with the useful information prepared by the organizer, consultable through the QR Code placed on the technical box;

h) He accept the final Judgment of non-admission, exclusion and/or disqualification and/or expiration, taken by the Organizer for the hypotheses provided for by these Regulations.

Art. 3 CONDITIONS - TERMS AND METHOD OF REGISTRATION

Paragraph 1. Registrations must be made **online**, through **Endu Portal**, on the Official Prosecco Cycling Page by completing the **online** admission request and payment by: credit card, satispay, bank transfer, attaching where required, the necessary documents as per art. 1 of these Regulations. Participants registering within **h. 24:00 of Friday 6 September 2024** will receive the bike front plate **customized** with Name, Pica Code for photos and QR Code with required sanitary information Participant communicated to the Organizer at the time of registration.

Paragraph 2. The Organizer has the right, at its sole discretion, not to admit Participants who have registered for the event. In this case, the fees paid will be refunded.

Paragraph 3. Subjects referred to in art. 3.6 and 4 of the ACSI Cycling Technical Regulations 2024 are not admitted to the Event and in any case, whoever has been sanctioned by Sporting and/or Ordinary Justice is subject to forfeiture of registration.

Paragraph 4. In the case of proven impossibility to participate **owing to health reasons**, the fee still paid will be reimbursed by the Organizer – after deduction of **€ 15.00** for secretarial costs and bank charges – **only** upon motivated request of the Participant to be sent by E-mail to: info@proseccocycling.it, together with the relating medical certificate as per **application for missed participation** ([see application](#)) **no later than 15 days** before the date of the Event under penalty of forfeiture.

Paragraph 5. Registrations open on **Monday 04 March 2024** and close on **Friday 20 September 2024** at **h. 24:00**. The closing of the registrations can be anticipated by achievement of the available places. It is possible to check the acceptance of the registration request by consulting **Endu Portal**, Official Page of Prosecco Cycling, within **5 working days** after sending the same request. Paragraph 6. The admission request for online registration of Candidates must be submitted by attaching: **ITALIAN LICENSED TOURING CYCLIST PARTICIPANTS**: a copy of the **valid medical certificate for competitive cycling** ([see fac-simile](#)), to be presented on **original** on the day of call for the collection of the technical box and gift box. Otherwise, participation is not allowed.

FOREIGN LICENSED PARTICIPANTS NOT OWING an U.C.I. license: a copy of the **valid medical certificate for competitive cycling** ([see fac-simile](#)), to be presented on the day of call for the collection of the technical box and gift box. Otherwise, participation is not allowed.

ITALIAN AND FOREIGN NON LICENSED PARTICIPANTS a **valid medical certificate for competitive cycling activities** ([see fac-simile](#)). All that must be presented **in original** on the day of **call** for the collection of technical box and gift box. Otherwise, participation is not allowed.

Paragraph 7. The Company and/or Sports Association is required to disclose and make known to its Members and/or Associates these Regulations. By signing the request of online registration, the President of the Company and/or Sports Association must ensure that each Cardholder and/or Associate owns the admission requirements expected by Prosecco Cycling 2024 Regulations and declare to exempt and hold harmless the Organizer from any civil and criminal liability for declarations not conforming to the truth and/or for omissions and/or for the lack of the required control.

Paragraph 8. Online registrations regarding both **italian** and **foreign** Candidates must be made by filling in the appropriate fields for: credit card, satispay, bank transfer.

Paragraph 9. The **replacing** of one or more Participants is allowed with the following procedure: send to info@proseccocycling.it the appropriate **application for replacement with other participant** ([see application](#)). Only after receiving the confirmation from the Organizer – attaching any documentation required - it will be possible to pay the **€ 15.00** fee for secretarial costs, indicating in the subject of the transfer the following: eg. "Replacing XX with YY". All to be completed until and no later than **Friday 6 September h. 19:00**.

Paragraph 10. The replacement can also be made on **Friday 27 September 2024** from **h. 15:00** to **h. 19:00** and **Saturday 28 September 2024** from **h. 09:00** to **h. 19:00** at the Registration Office, located in Tenuta Villa Sandi, Vadoobbiadene (TV), Via Tessere n. 1, Zecchei Locality, at a cost of **€ 15.00** plus the possible increase of **€ 16.00** (non-refundable in case of non-participation) to start the insurance policy referred to in art. 1 paragraph 1. point d) of these Regulations and the purchase of the chip (**optional**) at a cost of **€ 6.00** as referred in ar. 10 paragraph 3 of these Regulations.

Paragraph 11. Registration for Teams is allowed only for Participants registered with the same Club and/or Amateur Sports Association.

Art. 4 PARTICIPATION FEE

* If less than 10 participants, individual fees will be applied

C) GOLD REGISTRATION

From **22 December 2023** subject to availability

Starting from **€ 160.00** plus commissions

***IMPORTANT**

The purchase and use of the chip is in any case **optional**. Any purchase of the chip for Participants wishing to be included in the rankings: Individual Category, Fun Team, and/or Black Jersey can be done by **online** admission request by adding **€ 6.00** to the participation fee. The chip will be inserted in the technical box.

Paragraph 1. To take advantage of the reduced fee, Clubs and/or Sports Associations must register **contextually at least 10 Participants** at the same time. If this number is not reached, the individual fees referred to in letter **A** must be applied.

Paragraph 2. In the event that the limited number is not reached on schedule, the registrations will reopen on **Friday 27 September 2024** from **h. 15:00** to **h. 19:00** and **Saturday 28 September 2024** from **h. 09:00** to **h. 19:00** at the Registration Office located at Tenuta Villa Sandi, in Vadoobbiadene, Via Tessere n. 1, Zecchei Locality, at a cost of **€ 65.00**.

Paragraph 3. Cash payment is allowed up to a maximum amount equal to € 999.00 for each individual transaction or with credit card.

ITALIAN AND FOREIGN NON LICENSED in a Company and/or Sports Association **and licensed foreign Cyclists without U.C.I. license**, to participate **must necessarily** pay, **in addition to registration fee**, the amount of **€ 16.00** (non-refundable in case of non-participation) to start the multi-risk insurance policy asper art. 1 Paragraf 1 of The Regulations.

IT IS NOT POSSIBLE TO REGISTER FOR THE EVENT AND TO COLLECT THE TECHNICAL BOX AND GIFT BOX ON SUNDAY 29 SEPTEMBER 2024

The participation fee includes:

technical box with the faceplate and the single-use chip (**if required**); timing service; gift box; participation medal; medical assistance; technical and mechanical assistance including the free supply of inner tubes in case of puncture (excluding spare parts); road safety service; Gourmet refreshments points on the route; guarded bike parking; showers and toilets; **€ 15.00** voucher to be used for the **"Grand Tour Gourmet"**.

Art. 5 GOLD REGISTRATION

paragraph 1. Exclusive and reserved, starting in front row at Prosecco Cycling 2024, only upon payment of an increased fee to be made online by credit card, satsipay, bank transfer. **Gold** registration can be made from **22 December 2023 until** all available places are **sold out**.

Paragraph 2. It is mandatory to attach to Admission Request the documentation required by art. 3 Paragraph. 6 of the Regulations.

Paragraph 3. The **delivery service of the technical box and gift box** is also provided, **only** for **Gold** Participants, on **Sunday morning 29 September 2024** from **h. 6:30 to h. 7:30** in the Hospitality Area, set up at the Loggia Of the Municipality of Valdobbiadene, Piazza G. Marconi with the possibility to deposit one's bike until **17:00** in the guarded and reserved parking lot located at the rear of the Municipality House.

All services offered and reserved to **Gold** Participants can be consulted in detail on the official website of Prosecco Cycling.

Art. 6 MEETING AND DELIVERY OF THE TECHNICAL BOX AND GIFT BOX

Paragraph 1. The call is set for **Friday 27 September 2024** from **h. 15:00 to h. 19:00** and **Saturday 28 September 2024** from **h. 9:00 to h. 19:00** at Tenuta Villa Sandi, Valdobbiadene, Via Tessere n. 1, Zecchei Locality.

Paragraph 2. Each Participant must show:

a) the Card in original or legible photocopy (if licensed) or an identification document (if non licensed) and, in any case, **the valid original medical certificate for competitive cycling** ([see fac-simile](#)).

b) Touring Cyclist, Participants not licensed and **Foreigners licensed without U.C.I. license**, an identification document and the valid original **medical certificate for competitive cycling** ([see fac-simile](#)).

Paragraph 3. For Sports Companyclubs and/or Associations, To collect the technical box and gift box the President or Delegate of a Company and/or Sports Association may appear himself with the **list of participant by delegation for delivery of technical box and gift box** ([see the delegation](#)) and signature of the Contact Person, where it is declared that Participants registered in and owing a Card of the same Company and/or Sports Association are in possession of a **valid medical certificate for competitive cycling**.

Paragraph 4. Technical box and gift box will not be delivered on Sunday morning 29 September 2024. On demand of the Participant and in any case, no later than **Friday 6 September 2024**, it is possible to receive the technical box and gift box directly at home **only** for Participants domiciled in Italy. The cost of shipping is **€ 20.00 including VAT**. The request can be made on **Endu** Portal directly in the online request form for admission to Prosecco Cycling 2024.

Paragraph 5. Technical box contains bike front plate, single use chip (**if requested**) and **€ 15.00** Voucher for "**Grand Tour Gourmet**" and outside, QR codes with **relevant information** for participating in the event. Technical box is strictly personal and cannot be transferred to third parties, under penalty of immediate exclusion from the event. It is **strictly forbidden** to reduce, cut, roll up the bike front plate and/or hide any trademarks printed on it, under penalty of immediate exclusion from the event.**Paragraph 6.** Participants will also be given the discount voucher to access the "**Tiramisù Taste Event**", from **h. 11:30 to h.17:00** at Villa dei Cedri, Valdobbiadene, Via Piva. Participants not possessing the discount voucher and any accompanying Person, will be able to use the service only upon payment of **€ 5.00** per person. Children **under 18** can use paid service as long as they are accompanied by their Parents or an Adult.

Art. 7 DELEGATION FOR THE COLLECTION ON BEHALF THIRD PARTIES

Paragraph 1. Subjects charged to collect the technical box and the gift box on behalf of third Parties must consign a copy of an identity document together with the **delegation for delivery of technical box and gift box** ([see delegation](#)) as well as deliver the required documentation pursuant to art. 6 paragraph 2. points a) and b) of the Regulations.

Every single Participant, Delegate and/or President or Delegate of the Company and/or Sports Association is solely responsible for any related prejudicial effect deriving from failure to comply with the additional charges required and with exemption and indemnity of the Organizer from any liability.

Art. 8 ACCESS TO START-LINE

GOLD REGISTRATION: from **no 31 to no 350**

SINGLE GROUP: from **no 351** and beyond

Access to departure will be allowed from **h. 07:30 to h. 08.10** through the control provided by the Organizer in Valdobbiadene, Via Molini and Via Erizzo.

The Organizer reserves the right not to admit anyone who has not positioned the bike number plate **prominently** on the handlebars and/or does not adhere to the opening and closing times of the gate for access to the starting point and/or does not follow the instructions of the authorized personnel.

Art. 9 DEPARTURE TIME

Meeting h. 07:00 - Departure h. 08:30 in a **single** group.

Single route: km 100 – Gradient 1600 m.

Art. 10 TIMING AND CHIP

Paragraph 1. The timing service is provided by **EvoData** with **single-use chip** technology.

Paragraph 2. Personal chips cannot be used.

paragraph 3. The purchase and use of the chip is **optional!** Participants wishing to be included in the Rankings: Individual Category, Fun Team and Black Jersey can buy the chip by the **online** admission request adding € **6.00** to the participation fee, as per art. 4 of the Regulation.

Paragraph 4. The **single-use chip** and the instructions for use will be delivered in the technical box and it must be placed **only** under the saddle by the appropriate support provided.

Paragraph 5. Participants avoiding the chronometric surveys and/or to cover even only one of the three timed uphill stretches foreseen along the race course, will not be included in the Rankings.

Paragraph 6. No deposit is required for the use of the single-use chip.

Art. 11 RANKINGS AND AWARDS

Paragraph 1. INDIVIDUAL RANKING OF CATEGORY - it is drawn up in **alphabetical order** based on the **sum** of the times established in **Real Time exclusively** in the three timed uphill stretches foreseen and reported along the Route. However, it will also be possible to view the time taken in each single Climb and on the entire Route, with the category and absolute position, but not for Ranking purposes. All Participants will be included in the Rankings as per the following table of ACSI Cycling Categories:

Paragraph 2. Top finishers in each category will be awarded on the basis of the sum of the times detected in **Real Time exclusively in the three timed uphill stretches** foreseen and reported along the route.

Participants on e-bikes will not be included in the Individual Category, Fun Team and/or Black Jersey Rankings as they can compete exclusively for Team Rankings and/or We2gether Team. **Paragraph 3. TEAM RANKING** - it rewards Teams made up of men and women, **licensed with the same Team**, passing with the greatest number of Participants (**minimum 10**) on arrival **within 30"** between first and last of its Members, **within maximum time of 4h 45'** from departure. The First Team will receive the **Trophy** and **60 bottles** of

Conegliano Valdobbiadene Prosecco Superiore DOCG. Following four Teams will receive: **54, 48, 42, 36 bottles.**

Paragraph 4. Teams reaching the shortest time on entire Course will prevail in the event they placed the same number of Competitors **within 30"**. **Paragraph 5. FUN TEAM RANKING** - It rewards Teams made up of men and women, **licensed with the same Team**, achieving **best time on entire course (km 100)**. Team **must consist of (at least 5)** Participants passing on arrival **within 30"** between first and fifth of its Members. **Team not finishing the test with at least one woman in the top 5 will be penalized by 15 minutes.** First Team will receive **Trophy** and **54 bottles** of Conegliano Valdobbiadene Prosecco

Superiore DOCG. Following four Teams will receive: **48, 42, 36, 30 bottles.**

Paragraph 6. BLACK JERSEY (Maglia Nera) RANKING - It rewards Team made up of men and women **licensed with same Group**, recording **worst result** in the average distance of three timed climbs. Said average will be calculated by adding average time of three timed climbs obtained by **10 Members** of each Team achieving the worst result. Team

will receive **60 bottles** of Conegliano Valdobbiadene Prosecco Superiore D.O.C.G.

Paragraph 7. WE2GETHER TEAM RANKING – it rewards the Team made up of men and women, **licensed with the same group**, showing on arrival the best scenography paying tribute to Prosecco Cycling **20th anniversary**. This setting will enhance the concept of environmental sustainability together with Prosecco di Conegliano e Valdobbiadene Hills World Heritage Landscape. This Team will receive **60 bottles** of Conegliano Valdobbiadene Prosecco Superiore D.O.C.G.

Paragraph 8. Teams, Fun Team, Black Jersey and We2gether Team Ranking does not preclude the possibility for each participant to compete for Individual of Category ranking.

Paragraph 9. Each team registered with Prosecco Cycling can choose to take part in **all** rankings (Teams and/or Fun Team and/or Black Jersey and/or We2gether Team) while respecting **minimum number** of participants according to requirements of each ranking.

Paragraph 10. Ranking position will be communicated via SMS to all participants immediately after the finish and will be available online on **Endu** website from **h. 14:00**. Individual Category ranking, compiled in alphabetical order, will also include the time taken by Participants in each individual climb and over the entire route, with category and overall positions, but not for ranking purposes. For Team and Fun Team rankings, the top five groups will be awarded.

Paragraph 11. The supply of Conegliano Valdobbiadene Prosecco Superiore D.O.C.G. can be collected **only** on the same day of event no later than **h. 16:00**, at info point, Piazza G. Marconi in Valdobbiadene after showing identity document and/or membership card and **only after the arrival of last competitor**.

Paragraph 12. Special prize will be awarded to the foreign competitor coming from farther away, for having participated in Prosecco Cycling 2024.

Paragraph 13. In event of several Competitors coming from same place, prize will be awarded to oldest Participant, or to a woman with the same age.

Paragraph 14. Organizer reserves the right not to deliver prizes to third Parties and/or not to send them home, believing that they must be assigned exclusively **on the day of the Event** in the manner and at the established times.

Art. 12 ROAD CODE AND FURTHER RULES OF CONDUCT

Paragraph 1. During the Event the vehicular traffic is temporarily suspended for **2 hours**, between the starting and ending cars of the Event. Participants must however necessarily proceed with extreme caution observing the due precautions, because, without the knowledge of the Organizer and/or for facts unrelated to the Event and/or for unforeseeable situations caused by Third Parties for non-compliance with the provisions in force, or for misinformation of road users, risks to the safety of Participants may occur even during the suspension of vehicular traffic. In such cases, the Organizer is deemed exempt from any responsibility.

Paragraph 2. Competitors who will be overtaken by the ending car will have to continue the Race complying, under their own responsibility, with the Rules of the Road Code.

Paragraph 3. It is mandatory to keep the front plate on the bike until the end of the Event.

Paragraph 4. It is mandatory to wear an approved protective helmet to be worn until the end of the event.

Paragraph 5. For anything not covered by these Regulations, please refer to the enforcement of ACSI Cycling for amateur and tourism cyclo activities which all Participants are required to comply with.

Paragraph 6. Participants will also be required to respect the state of the places and not to throw waste along the streets, having to put them in the appropriate containers at the refreshment points. Competitors who do not respect the state of the places and/or who throw garbage outside the marked spaces and/or who, in any case, do not comply with a correct and/or civil behavior during the event will be immediately disqualified.

Paragraph 7. In order to ensure the best outcome of the Event, assistance by private vehicles (scooters, motorcycles, cars, etc.) including mechanical assistance (already provided by the Organizer) is forbidden in the wake of the race or simply on the side of the road, under penalty of immediate exclusion from the Event of the Participant who will follow by unauthorized Subjects.

Paragraph 8. "Broom" vehicles are provided for the recovery of Participants and for the transport to the finish area of all Participants who, for any reason, do not completed the planned race course.

Art. 13 HEALTH SERVICE
